The Community Foundation at a Glance

MISSION

The mission of the Community Foundation Serving Greeley and Weld County is to facilitate the desires of donors in order to develop growing endowments which will serve to improve the quality of life in our communities.

HISTORY

In 1997, the Greeley Area Foundation and the Weld Community Foundation completed a merger to form the Community Foundation Serving Greeley and Weld County. It was the foresight of the founding board members to create a single entity that has since provided more than \$8 million in support to Weld County organizations over the past ten years. Today, the Community Foundation has over 110 funds and assets of nearly \$10 million.

WHAT IS A COMMUNITY FOUNDATION?

A community foundation is a charitable organization created by and for a community of people. It is supported by local donors and governed by a board of private citizens who work toward the greater good of the community. Funds come from a variety of sources including bequests and corporations, and are

invested in perpetuity. The earning on investments are then distributed to worthy organizations or causes. Today, more than 1,000 community foundations exist around the world.

GRANTMAKING

The Foundation awards most of its grants to 501(c)(3) nonprofit organizations that support projects and programs that benefit Weld County citizens, meet community needs and test new ideas. We annually award more than 250 grants ranging from a few hundred dollars to several thousand dollars. Some of our grant dollars are directed to specific areas of need such as youth and arts programs. Other grant dollars are recommended by donor-advisors to support causes that matter most to them.

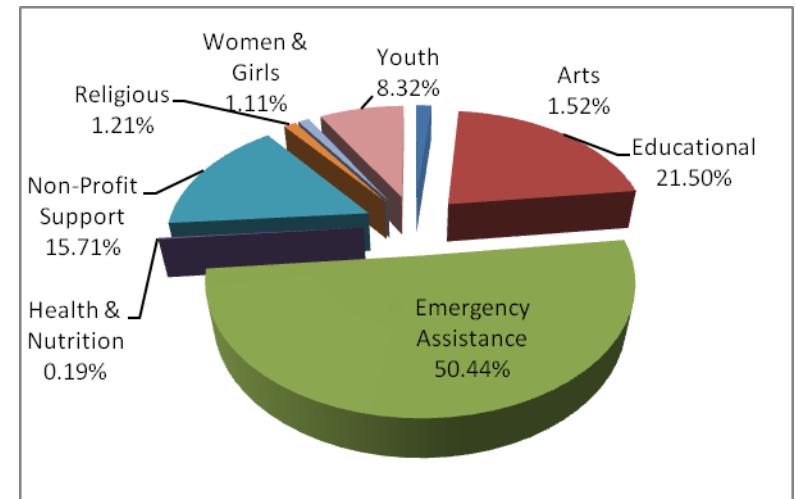
STEWARDSHIP

We are stewards of donor dollars, ensuring that the wishes of our donors are met. Our diversified investment strategy is guided by our board and our investment committee.

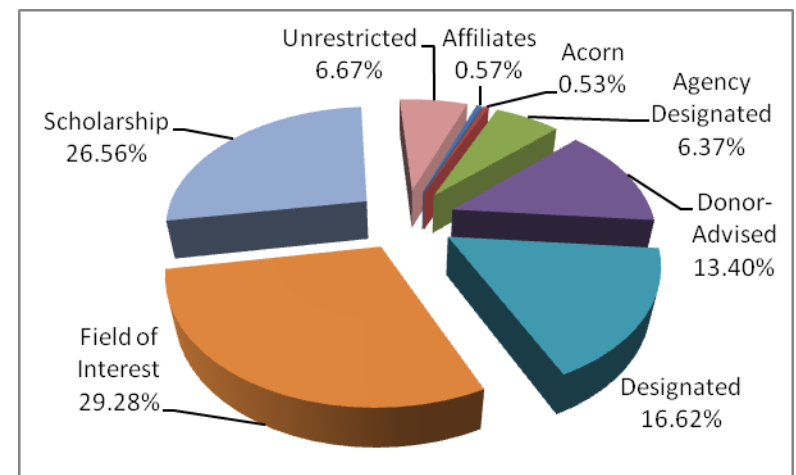
