Message From the Board Chair and President



Dear Friends and Neighbors,

The generosity and good works behind every deed experienced by the Community Foundation over the past year have come from all corners of our county. In the midst of this diversity, there are some common themes. Those involved have cared deeply about Weld County, and all have made a difference in the life of another that will last forever. Ten years ago, our founders had the dream that the Community Foundation Serving Greeley and Weld County would enhance the quality of life for all residents in our many communities far into the future, and their foresight is making that dream a reality.

We are often asked the question, "What is the Community Foundation?" A community foundation is an organization that is difficult to describe because it plays so many roles in our community. Our primary role is to create permanent endowment funds for Weld County. Our donors give because they want to make a difference by addressing the issues that affect our communities. With an endowment fund, the original gifts will remain here forever while grants continue to be generated from the earnings of the fund to support worthwhile causes. Although our primary purpose is to grow endowments, our measure of success is not growth for growth's sake but for what those funds can do. Other roles include being a grantmaker and providing leadership related to philanthropic community projects.

This past year has been one of growth and opportunity for the Community Foundation by:

- the addition of 23 new funds, including 6 new agency partners;
- awarding grants totaling \$734,944;
- nearly tripling the number of scholarships awarded;
- increasing the number of Centennial Society legacy gift members;
- presenting 5 workshops to build the capacity of local nonprofits; and
- collaborating with the Colorado Nonprofit Association's statewide Generosity Project.

To our donors, volunteers and nonprofit partners, we would like to say "thank you" for another successful year. The need for charitable dollars continues to grow as our communities grow. We are fortunate to live in Weld County where generous and caring people make things possible. We invite you to consider a gift to the Community Foundation. Working together, we are here *For Good...For ever.*

Fund Highlights—Union Colony Civic Center Funds

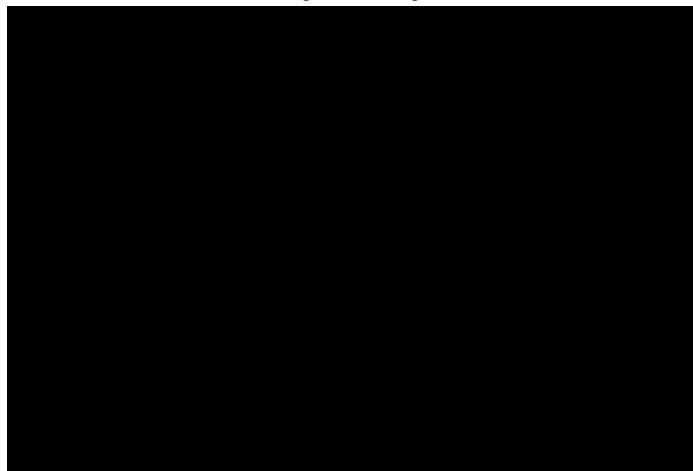

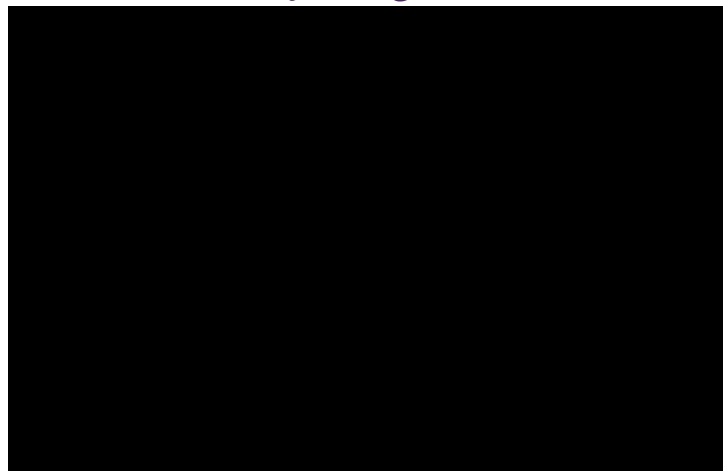
The Union Colony Civic Center (UCCC) provides Northern Colorado and the surrounding areas with a variety of the best local, regional and national entertainment. In early 2007, the Phyllis and Glenn McDonald Memorial Fund for the Performing Arts was established by their son, Bill, to provide support to the Union Colony Civic Center. The fund will assist the UCCC to undertake community activities and programs in the performing arts which are specifically designed for and aimed at children under the age of nineteen and which seek to engender in children from all walks of life an interest in and appreciation for the performing arts. Future donors may contribute to this fund to enhance the performing arts for children. In addition, Bill McDonald also established a designated endowment fund as a source of unrestricted income for the use of the UCCC. It also provides a means for future gifts to the Union Colony Civic Center.

The UCCC created a pass-through fund to accept donations for the purpose of providing immediate support to programs, events, activities, training and facility needs of the Union Colony Civic Center while the unrestricted endowment fund grows.

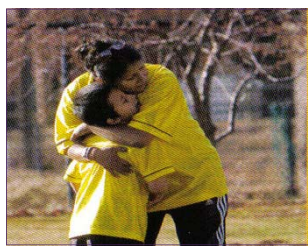
